**Minutes of the meeting of the Bid-Evaluation Committee held on 09-05-2017**

The following members were present in the opening of the bid documents:

1. Mrs. Nazreen Ahmed, ACS., Additional Commissioner, GMC.
2. Sri. Deepak Gogoi, Chief Engineer, GMC.
3. Sri. Deepankar Kakati, OSD, PMC, GMC.
4. Sri. Manojit Bujarbarua, EE, Garage, GMC
5. Sri. Priyanshu Prawal Thakuria, Town Planning Specialist, GMC.

Three bids were received. The participating bidders are as follows –

1. Kamrup Constructions (P) Ltd.
2. Punjab Engineering Company.
3. Maverick Technologies

It was observed that –

- 1) Kamrup Constructions (P) Ltd. has not submitted the bid security amount of Rs 4,00,000.00 and made a request to be exempted under the Single Point Registration Scheme of NSIC, SSI units registered under NSIC.
- 2) Maverick Technologies has not submitted any bid security and bid document fee.
- 3) Punjab Engineering Company has submitted all the requisite documents.

After a threadbare discussion, the Committee recommended the following –

In the minutes of the prebid meeting it was made clear that no benefit shall be accorded in respect to Single Point Registration Scheme of NSIC, SSI units registered under NSIC as it is not mentioned in the RFP. The same is uploaded in the GMC website. But Kamrup Construction (P) Ltd and Maverick Technologies has not fulfilled the required conditions as per the RFP.

As such, the Committee decided to go for the technical evaluation of Punjab Engineering Company only and rejected the other two proposals. In the technical evaluation, it was found that Punjab Engineering Company managed to obtain a score of 80. The marks needed to qualify was 75. Hence, Punjab Engineering Company qualifies the technical stage of the bidding process.

The Committee proposes that the financial bid of the successful bidder may be opened.

The meeting ended with vote of thanks to the chair.
